AMENDING TRIBAL CODE CHAPTER 11: MEMBERSHIP CODE SECTION 11.102 AND

CHARGING THE HEALTH DIVISION WITH PUBLIC HEALTH AUTHORITY

WHEREAS, the Sault Ste. Marie Tribe of Chippewa Indians holds its Member's data and personal information in confidence; and

WHEREAS, the Board of Directors has resolved not to release enrollment information except in situations where the privacy and confidentiality of the Members is maintained; and

WHEREAS, American Indian communities and Tribes do not have adequate cancer statistics to plan appropriately and allocate cancer prevention, screening, or treatment funds where they are most needed. Tribes need Tribe-specific cancer incidence data, not statewide or regional data; and

WHEREAS, cancer and disease registries around the nation realize that their statistics for American Indians under-estimate the burden of disease in these communities because American Indian individuals with disease are regularly reported as white by their doctors; and

WHEREAS, child abuse investigation, prevention and prosecution agencies need access to proof of parentage and membership information for the purposes of protecting children and promoting the welfare of the Tribe and its members, including the most vulnerable of those members; and

WHEREAS, the Federal HIPAA law specifically and clearly includes language mirroring the language of this amendment which allows doctors and health departments to share this exact same sort of information for the exact same reasons; and

WHEREAS, IHS, the Centers for Disease Control, the Tribe's Health Department, and the Tribal Registrar have all worked to resolve these issues in a manner that protects the personal information of our members in a reasonable manner while also dealing with the public health and safety concerns of the Tribe.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of the Sault Ste. Marie Tribe of Chippewa Indians hereby amends tribal Code Section 11.102, by amending subsection (2) and adding subsection (3) to read:

(2) Information contained in the membership files of the Tribe is confidential. It shall be released only pursuant to this Chapter or to any subsequent resolution of the Board of Directors.

(3) Permitted disclosures. Information contained in the membership files of the Tribe may be disclosed for:

(a) the normal course of business of the Tribal offices; or

(b) working with agencies of the Federal government for the purposes of establishing an approved Tribal roll, or in support of an application of the individual for a Federal program if the information is necessary to prove the individual's eligibility for the program; or

(c) a public health authority of the Tribe, including the Health Division of the Tribe, a state, or the federal government that is authorized by law to collect or receive such information for the purpose of preventing or controlling disease, injury, or disability, including, but not limited to, the reporting of disease, injury, vital events such as birth or death, and the conduct of public health surveillance, public health investigations, and public health interventions; or, at the direction of a public health authority, to an official of a foreign government agency that is acting in collaboration with a public health authority; or

(d) a public health authority or other appropriate government authority authorized by law to receive reports of child abuse or neglect.

BE IT FURTHER RESOLVED, that the Tribe's Health Department is hereby charged with the task of acting as the Public Health Authority of the Tribe, to manage and control public health problems, to prevent disease, prolong life and promote health through organized efforts and informing the choices of society, organizations, public and private, communities and individuals.

BE IT FINALLY RESOLVED, that the Health Department may enter into collaborative agreements with state and federal agencies to fulfill these public health duties.

CONSULTATION AGREEMENT

BETWEEN

CHIPPEWA COUNTY, MICHIGAN

AND THE

SAULT STE. MARIE TRIBE OF CHIPPEWA INDIANS

1. **Parties**

This agreement is entered into by and between Chippewa County, Michigan, a municipal corporation of the State of Michigan, (the "County") and the Sault Ste. Marie Tribe of Chippewa Indians, a federally recognized Indian Tribe, (the "Tribe").

2. Purpose

The purpose of this agreement is to foster improved government-to-government relations and cooperation between the County's Board of Commissioners and the Tribe's Board of Directors by creating a mechanism for regular consultation on issues of mutual interest or concern.

3. Liaison Committee

The parties agree that it is in the best interests of their respective governments for elected officials of the County and of the Tribe to meet and confer on a regular basis to discuss matters of mutual interest and concern. The parties therefore agree to create a Joint County-Tribal Liaison Committee to be comprised of at least two members of the County Board of Commissioners and at least two members of the Tribal Board of Directors who shall meet and confer at least at least once every three months, provided that the Committee is encouraged to meet at least once every two months during the first year of its existence. The County shall host the first meeting; the Tribe shall host the next meeting; and the parties shall thereafter endeavor to alternate the hosting of the meetings. Each party is encouraged to host meetings at a variety of locations, to provide a tour of each such facility as a part of the meeting, and to share information regarding the host location and the activities and/or services provided at that location. The

meetings of the Committee shall be conducted informally in a manner designed to facilitate the free and frank exchange of information and ideas.

4. No Effect on Existing Agreements between the Parties

The County and the Tribe have entered prior contracts and agreements on a variety of topics. These prior contracts and agreements remain in force and effect and are not affected by this Consultation Agreement.

5. Effective Date and Term of Agreement

This agreement shall take effect upon adoption of appropriate resolutions, respectively, by the County Board of Commissioners and by the Tribal Board of Directors, each approving and authorizing their respective Chairpersons to sign this Agreement and shall remain in effect until rescinded by either party in writing.
