**APPROVAL OF ADDENDUM TO SETTLEMENT OF LAND CLAIM**

WHEREAS, the Sault Ste. Marie Tribe of Chippewa Indians is a federally recognized Indian tribe organized under the Indian Reorganization Act of 1934, as amended; and

WHEREAS, on December 20, 2002, the Tribe entered into a Settlement of Land Claim ("Settlement") with the State of Michigan to resolve and extinguish the Tribe's claims to lands located in Charlotte Beach, Michigan; and

WHEREAS, the Tribe has determined that an Addendum to Settlement of Land Claim ("Addendum") (attached hereto and made a part hereof) is necessary to fully implement the Settlement and ensure that the Tribe's interest in gaming on replacement lands in Romulus, Michigan is protected; and


WHEREAS, the State of Michigan has agreed that the Addendum is appropriate and wishes to enter the Addendum.


NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of the Sault Ste. Marie Tribe of Chippewa Indians hereby approves the Addendum.

BE IT FINALLY RESOLVED, that the signature of the Chairman of the Tribe on the Addendum shall constitute the approval of the Board of Directors of the Sault Ste. Marie Tribe of Chippewa Indians.

**CERTIFICATION**
