Administrative WHEREAS, it has become necessary for the Chief Financial Officer to be given access to internal funds for cash flow purposes.

NOW, THEREFORE, BE IT RESOLVED the Chief Financial Officer is granted authority to access internal funds, up to ten million dollars, for cash flow purposes. The per annum rate shall be 12% and any expenditures made one year beyond the effective date of this resolution shall carry an additional 1%.

BE IT FURTHER RESOLVED that the Chief Financial Officer shall provide a detailed report of monetary expenditures to the Board of Directors.
