## Home Improvement FY 2008 Budget Modification July 2008

**2020 Home Improvement**: Request to increase BIA revenue \$247,500. These funds are allocated for home rehabilitation and home replacement based off the plan submitted by the Program Manager. Increase consulting/contracting \$247,500.

#### **Program Manager Justification**

The Sault Ste. Marie Tribe of Chippewa Indians had received funds from the Bureau of Indian Affairs in 2008 based on a work plan that was submitted in November, 2007. Two families were selected for services, one receiving major rehabilitation and one receiving a home replacement. However, upon the home visit with the elder to receive a new home, he declined and withdrew his application as he is in Tribal Housing now and feels his health is very poor to be able to maintain a new home. I contacted the Bureau on this and they have approved me to continue on the list of families on the 2006 work plan until all funds have been exhausted.

## Resolution Title Budget Modification for Home Improvement Program -Cost Center 2020

What Resolution is designed to do: (How will impact Tribe, members, services, government, local community, etc. How many tribal members will it serve, etc.)

On July 13, 2006 our Tribe submitted a work plan to the Bureau of Indian Affairs for potential funding for families who scored points based on their income; family size, elderly and disabled applicants. This plan was approved and supported by our Board of Directors on July 11, 2006 and submitted. On August 10, 2006, we received notification from the BIA that we could amend that plan with a deadline of September 1, 2006. On August 31, 2006 an amended plan was submitted as we had received a couple more applications that qualified for the program. On October 9, 2006, Kelly Smart sent a letter to the Bureau on clarification on the funding we received from the Office of Self Governance, Ken Rhinfield. In addition, on this letter we requested to spend out left over funds on a family that was identified on the 2006 work plan, but not funded. Our Tribe received the Bureau of Indian Affairs response to this letter on October 23, 2006 detailing the award, deadline submission to the work plan and approval to use left over funds on a family identified on our 2006 work plan. On July 2, 2008 Kelly verbally spoke to the Bureau and requested approval to eliminate a elder from the work plan funds because he withdrew his application. In addition, on that same day it was discussed to move one elder in SSM from a category B to a category C-1 replacement. The Bureau stated that they would follow up with a letter that we did not receive so a written request was submitted to provide our Tribe with the Bureau support on eliminating the elder in St. Ignace and moving the elder in the Sault to a replacement on July 28, 2008. The Bureau's written approval has been received so we can move forward on servicing the two elderly families immediately and continue down the 2006 work plan until all funds have been exhausted.

# RESOLUTION NO: 2008-180

## AMENDING TRIBAL CODE CHAPTER 21: HUNTING AND INLAND FISHING BAITING BAN

WHEREAS, on August 25, 2008, the Michigan Department of Natural Resources documented a case of Chronic Wasting Disease in a captive whitetail deer in Kent County, Michigan; and

WHEREAS, pursuant to the DNR's Surveillance and Response Plan for Chronic Wasting Disease the DNR has enacted a ban on all baiting of deer in the Lower Peninsula due to the discovery of the presence of a serious disease; and

WHEREAS, the Inland Consent Decree at Section XIII states that "As long as the State enforces the following prohibitions, the Tribes shall prohibit their members from: (a) using bait as a method of take in the Hunting of deer and elk where prohibited by the State for the purposes of controlling disease..." and

WHEREAS, the MDNR baiting ban therefore requires the Tribe to enact its own baiting ban.

NOW, THEREFORE, BE IT RESOLVED, that Tribal Code Chapter 21: Hunting and Inland Fishing, Section 21.519(5) is created as follows:

"(5) Notwithstanding subsection (1) above the baiting of deer in any manner whatsoever in the Lower Peninsula is prohibited."
