LAND PURCHASE FOR CULTURAL AND TRADITIONAL USE

WHEREAS, the Sault Ste. Marie Tribe of Chippewa Indians ("Tribe") is defined as a land-poor Tribe due to Colonization efforts, historic removal policy, and forced settlements and sales; and

WHEREAS, it is in the best interest of the Tribe and all of its citizens to increase land base within its Traditional homelands to protect our way of life now and for seven generations to come and as a response to the negative health and economic impacts of the COVID-19 pandemic, that encourages outdoor activity and increases access to healthy food which improves mental and physical health outcomes.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors authorizes the Treasurer or his designee, to negotiate the purchase of the properties on the listings attached and incorporated as Exhibit A up to the listing price utilizing unobligated ARPA funding.

BE IT FURTHER RESOLVED, upon successful negotiations and purchase, that the Board of Directors authorizes the land be used for future sustainability for cultural and traditional purposes, including but not limited to: Gathering of traditional medicines, hunting, foraging, fishing, fasting, food sovereignty, food security, and any other cultural or traditional activity that will sustain the environment and/or community in which historically inhabited these lands.

BE IT FINALLY RESOLVED, that the Board of Directors hereby authorizes and approves the Tribal Vice-Chairman, or his designee, to execute any and all documents as may be necessary and appropriate to carry out the terms, conditions and intent of this Resolution and authorizes all internal administrative budget modifications from the authorized budgeted funding.
