"Smoking" of commercial tobacco means inhaling, exhaling, burning, carrying or possessing any lighted or heated commercial tobacco products, including but not limited to cigars, cigarettes, pipe tobacco, hookah pipes, or using any battery operated "Electronic cigarettes" or other electronic

nicotine delivery systems.

Government Services

To ensure the health and comfort of our guest and team members the Kewadin Shores Hotel prohibits smoking in the hotel rooms, hotel lobby, the entrance area to include Northern Rewards and the sitting area. Smoking is only permitted on the gaming floor including the bars.

The smoking of commercial tobacco products is prohibited within 25 feet of outside entrances, operable windows, and ventilation intakes of enclosed areas where smoking is prohibited, so as to ensure that secondhand smoke does not enter those areas.
