APPROVING AMENDMENT TRIBAL VEHICLE POLICY

WHEREAS, the Sault Ste. Marie Tribe of Chippewa Indians has entered into a self governance compact with the United States, Bureau of Indian Affairs (BIA); and

WHEREAS, pursuant to the self governance compact, it is necessary that the Tribe have in place a Tribal Vehicle Policy at least as good as the policy adopted for BIA employees; and

WHEREAS, pursuant to the requirements of 5 CFR Part 930 and the Department of the Interior's Motor Vehicle Safety Policy, 485 DM 16, and the Self Governance Compact, the Tribe must certify that it will self-administer a motor vehicle operation policy that promotes the safe and prudent operations of motor vehicles while performing duties to implement the terms of the Agreement, and the Tribe's policy is either comparable or superior to the May 3, 2006 Motor Vehicle Operation Policy for the BIA issued by the Associate Deputy Secretary; and

WHEREAS, pursuant to United States Presidential Executive Order 13513, the Tribe has been encouraged to adopt its own policies about texting while driving and to educate its employees and contractors about texting while driving; and

WHEREAS, this Board of Directors has reviewed the attached Tribal Vehicle Policy, and has determined that this policy as written is essential for the safety and welfare of our staff, contractors, and the public that the Tribe serves; and

WHEREAS, in order to ensure the highest levels of safety are maintained at all times, this Board has determined that it is in the best interests of the Tribe to suspend the driving privileges of any employee arrested for, charged with, or convicted of a major vehicular violation, such as Reckless Driving, Driving While Intoxicated (DWI), Driving under the Influence (DUI), or Leaving the Scene of an Accident, or any equivalent offense in other jurisdictions.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of the Sault Ste. Marie Tribe of Chippewa Indians hereby approves the attached Tribal Vehicle Policy.

BE IT FURTHER RESOLVED, that this policy shall be made available to all employees, and a signed acknowledgement of receipt shall be obtained from every employee for whom driving is an essential element of their position, both current employees within the next 30 days, and all future employees upon their placement in a position requiring driving.

AMENDING CHAPTER 71: SAVING OUR YOUTH:

ESTABLISHING THE BIG BEAR ARENA AS AN ALCOHOL FREE ZONE

WHEREAS, the Sault Ste. Marie Tribe of Chippewa Indians has assumed the responsibility to govern the Tribe and its operations in a manner designed to minimize the hardship and injuries inflicted on the community; and

WHEREAS it has been understood for generations that alcohol and drugs are injurious to the body of the people who choose to use them, and also to the community as a whole; and

WHEREAS, the Big Bear Arena was created as a community recreation and child development facility; and

WHEREAS, it is the judgment of this Board of Directors that drugs and alcohol should never be consumed in a community recreation or childhood development area, and that the establishment of the Big Bear Arena, and the surrounding property including the nature trail, playgrounds, parking lot, and access areas will contribute to the betterment of the community as a whole, and will limit the creation of negative impressions in the minds of our children.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Directors of the Sault Ste. Marie Tribe of Chippewa Indians hereby mandates that the Big Bear Arena, together with the surrounding property including the nature trail, playgrounds, parking lot, and access areas shall be and hereby is declared a drug and alcohol free zone.

BE IT FURTHER RESOLVED, all entry areas within the Big Bear Community Recreation Complex, and all drive ways, shall be posted with visible signage declaring the property to be drug and alcohol free.

BE IT FURTHER RESOLVED, that any person entering these areas with either drugs or alcohol in their possession shall be an unwelcome visitor, who shall be removed from the premises by the management, reported to law enforcement as a trespasser, and prosecuted by the Tribal Prosecutor to the fullest extent of the law.

BE IT FINALLY RESOLVED, that Tribal Code Section 71.1202 is hereby amended to add subsection 71.1202(1)(m), which shall state:

(m) possesses any alcohol or illegal drug while inside an area posted as a drug and alcohol free area.

And further amends subsection 71.1202(1)(1) to delete the period at the end of the sentence and replace the period with "; or"

OPPOSITION TO MI H.B. 5834 AND THE RECREATIONAL HUNTING OF WOLVES IN MICHIGAN

WHEREAS, in the Anishinabe biimaadziwiin (our Indian way), the wolf (Ma'iiangan) is the Anishinabek's oldest and original companion; and

WHEREAS, Ma'iiangan is one of our sacred clan creatures and is not hunted because it is a descendent of Pucky Wuss (Nana bush's companion provided by Gitchi Manitou); and

WHEREAS, Ma'iiangan has only marginally reestablished populations again where they were once extirpated within 1836 Ceded Territory; and

WHEREAS, management actions of the State of Michigan can significantly impact our nation's ability to interact with and manage for *Ma'iiangan*; and

WHEREAS, we do not believe broad-based population control measures in the form a wolf hunting season are warranted or will be effective at achieving management outcome sought in H.B. 5834; and

WHEREAS, effective tools currently do exist for citizens and resources managers and are authorized in State of Michigan Public Acts 290 and 318;

NOW, THEREFORE, BE IT RESOLVED, that the Sault Ste. Marie Tribe of Chippewa Indians is unequivocally opposed to House Bill 5834 which would designate wolves as a game species under State of Michigan law and allow for a wolf hunting season.

BE IT FURTHER RESOLVED, that the Sault Ste. Marie Tribe of Chippewa Indians is unequivocally opposed to hunting of wolves within the 1836 Ceded Territory.
